**60/11 To review a letter received from Tweseldown Infant School Governors regarding the Parish Councils comments on planning application 11/00001/MAJOR**

The Planning committee reviewed a letter from the Governors at Tweseldown Infant School that had previously been circulated to all councillors. The Governors were unhappy that the Parish Council had objected to the removal of a school on site as in their opinion the best solution to meet the educational needs of local children would be to expand the existing local schools.

The clerk was asked to send a response stating that the Parish Council had consulted with the community by holding a public meeting and had made their decisions at a public planning meeting. The Parish Council believed that a school on the QEB site would reduce the impact on local traffic which was one of the main concerns raised by the public, that developing the local schools would lead to a reduction in open space available for the children and for parking vehicles used by staff and that the proposed site at QEB offered a lovely setting for a school with plenty of open space and access to sports facilities. The clerk was asked to offer the Governors an opportunity to meet with the Parish Council so that they could discuss the matter further.
